ORDINANCE NO. 86

AN AMENDING ORDINANCE NUMBER 50 OF THE BOROUGH OF INDIAN LAKE.

BE IT ENACTED AND ORDAINED AND IT IS ENACTED AND ORDAINED THAT THE ORDINANCE NUMBER 50 OF THE BOROUGH OF INDIAN LAKE BE AMENDED TO READ AS FOLLOWS:

Section 501. A. 3. (d): One (1) boat dock, boat house or boat slip, deck and storage locker not to exceed thirty-two (32) square feet in area or (4) feet in height and which must be an integral part of the deck or dock; a permit for the purpose of erecting the above shall be issued to any lot owner who has a dwelling completely erected in the Borough of Indian Lake that complies with all established ordinances as defined by Indian Lake Borough.

Existing boat docks, boat houses, decks or boat slips must be kept in good and safe repair as to not affect the health, general well being and welfare of the residents of the Borough of Indian Lake. Failure to comply will result in removal of said boat dock, boat house, deck or boat slip and no permit will be issued for a replacement boat dock, boat house, deck or boat slip.

Section 601. A. 1.: No structures, temporary or permanent shall be placed or erected thereon except one (1) boat dock or boat lift, a deck which shall not extend more than twenty-five (25) feet into the park area, a storage locker not to exceed thirty-two (32) square feet in area or four (4) feet in height and which must be an integral part of the deck, dock or lift or stairway which may only be installed for access if the terrain indicates it is necessary. If the storage locker is situated on the boat dock, deck or boat lift it must be erected or placed on the land side of the area; a permit for the purpose of erecting the above shall be issued to any lot owner who has a dwelling completely erected in the Borough of Indian Lake that complies with all established ordinances as defined by Indian Lake Borough.

Existing boat docks, decks or boat lifts must be kept in good and safe repair as to not affect the health, general well being and welfare of the residents of the Borough of Indian Lake. Failure to comply will result in removal of said boat dock, deck or boat lift and no permit will be issued for a replacement boat dock, deck or boat lift.

Section 1201. A. 2. (c): No parking of any type of motor vehicle is permitted within the park area; except materials may be transported thru the park area for constuction or maintenance on park area or structures therein.
