








View from our lot toward clear Run.



Please notice Ice (thicker with snow on it) in the background – Thin clear ice in the foreground – unfrozen water around the docks because of the bubblers.





This is taken from my in-laws lot (6 lots toward Clear Run from our lot).

It is very visible that the thin ice continues toward Clear Run another 3 to 4 lots from my in – laws lot. That is approximately 10 or 11 lots from our lot.




Taken 3/24/2013 (7:30 am)

This was a relatively calm day. When the winds are strong, this happens quicker.




Taken 3/27/2013 (4:04 pm)

This picture was taken from the right corner of our property, facing the lake. Again, the ice is solid in the background. Warmer water created by the bubblers is pushed by the prevailing wind to our property and will continue toward Clear Run. The semi frozen material is nothing more than slush as shown in the following picture.

Picture taken from the left corner of our property looking at the lake. This is the leading edge of warmer water created by the bubblers. Easily seen is the extent of the slushy water that is present. As stated in several previous photos, this warmer water is being driven by the prevailing wind.
